- I, Keith Hunter, declare under penalty of law as follows:
- 1. I am duly authorized to make this Declaration (the "**Declaration**"). Unless otherwise stated in this Declaration, I have knowledge of the facts set forth herein and, if called as a witness, I would testify thereto:
- 2. I am the founder, President, and CEO of the Hawai'i-based Dispute Prevention & Resolution, Inc., in which I maintain an active ADR practice. During my 41-year career in dispute resolution, I formerly served as the founder and Regional Vice President of the Hawai'i office of American Arbitration Association and as the Executive Director of the Center for International Commercial Dispute Resolution.
- 3. I regularly work closely with trial and settlement judges in both the State and Federal courts as a co-mediator and settlement master in a wide range of complex civil and personal injury matters.
- 4. I have successfully served as a Mediator in approximately 6,000 disputes, claims, and lawsuits including:
